

1. Contracts formed between BookNerd and users as a result of using this service shall be governed in all respects by English law and all such users hereby submit to the non-exclusive jurisdiction of the English courts.
2. The start of the contract between the client and BookNerd will take place on signing and the attaching to the book the submission label and the placing it within one of BookNerd's BookDrop facilities.
3. The goods submitted to BookNerd by the client for the purpose of resale will remain in BookNerd's possession until completion of the contract between you the client and BookNerd takes place. However if the completion of our contract is not possible from our side for the reason of inability to contact you after a period of two months after the sale of your goods, the reason for contacting you being that we are unable to forward the proceeds of the sale of your goods to you due to incomplete or wrong information provided by you in the book submission label, we reserve the right to continue the sale and any monies gained will be kept by BookNerd or the book disposed of or donated to charity.
4. Completion of the contract between the client and BookNerd will take place on dispatch/transfer of the proceeds from the sale of your goods through the means specified by you in the book submission label. This will be deemed to be our acceptance of your offer and to have been effectively communicated to you. This is to be interpreted and enforced with the laws of England, in its entirety and will be subject to the jurisdiction of the English courts.
5. BookNerd assumes no liability in case of loss, damage or theft of your goods for reasons which are beyond our control.
6. BookNerd will charge a fee of 17.5 per cent of the final resale value of your goods should they be sold within nine months of the start of our contract. Should the client have selected on submission of the goods, the option of either "continued sale" or "charitable donation", both of these applicable only if the book is not sold within the first nine months after submission, the fee charged by BookNerd will increase to 23.5 per cent of the final sales price, to cover increased storage costs. If the client has selected to be paid via cheque, they agree to that a fee of 79p per cheque issued will be deducted from the proceeds to the client, in order to cover the cost of postage, admin and bank fees. If the client has selected to be paid via Bank Transfer, they agree to that a fee of 39p per Transfer issued will be deducted from the proceeds to the client, in order to cover the cost of admin and bank transfer fees.
7. BookNerd reserves the right to charge clients who have selected pickup option, 17.5% of the final sale price of their book if it sells during the nine month period. After the 9 month period is complete an unsold book in the free pickup category can be collected free of charge from BookNerd. Books within the free pickup category sold after the 10th month will incur a handling charge of 48.5% of the final sale price.
8. BookNerd will not charge the client for collecting your goods from our office after expiration of the first nine months of our contract and only if on submission of the goods the client has selected the option of "Return Option" and this condition is only valid for a United Kingdom postal address. BookNerd may charge the client a fee of GBP 7.99 (total consignment weight 0KG - 5KG) and GBP 9.99 (total consignment weight 5KG+) if the client would like their goods returned by post, however they must of selected "PICKUP OPTION" on the submission label.
9. BookNerd reserves the right to hold goods submitted by the client for the purpose of resale, for a period of nine months after the start of the contract. Should the client wish to have their goods returned before the nine months expire, we will charge a handling fee of GBP 10 per kilogram of weight of the goods to be returned.

10. If the client has selected continued sale, or charitable donation on their submission labels, BookNerd reserves the right to hold goods submitted by the client for the purpose of resale after the period of nine months has elapsed. Should the client wish to have their goods returned, we will charge a handling fee of GBP 10 per kilogram of weight of the goods to be returned.
11. BookNerd reserves the right to donate goods which are under the continued sale or charitable donation bracket, after having spent a reasonable amount of time in storage and where it is evident to BookNerd that there is not enough demand for the book(s) or the book is not in a saleable state, or where the potential revenue received for the book would be lower than the cost of returning it to the owner.
12. BookNerd reserves the right to automatically select charitable donation as the clients after nine months option, If the client has not selected either pickup option, continued sale, or charitable donation on the submission label,
13. BookNerd reserves the right to price the goods supplied by the client for resale, outside the price bracket selected by the client. This pricing decision will be made by BookNerd based on an assessment of the condition and current relevance to its course.
14. BookNerd reserves the right to refuse the resale of goods supplied by a client. In this event we will allow the goods to be collected by the client free of charge from BookNerd.
15. Returns of goods can take up to 28 days to reach the client due to reasons beyond our control.
16. In the unlikely event of termination of the BookNerd service, we will allow the collection of any books held for a client, no matter what their status, free of charge from an address supplied by BookNerd.
